## **Privacy statement:**

The Law Office Thomas Tzotzou & Associates, Olympiou Diamanti Str. 14, GR-54626 Thessaloniki/Greece take the protection of personal data of our clients and the interested persons very seriously and comply with the data protection legislation. In no case will the collected data be sold. The following information explains how our Law Office guarantees this protection and which data is collected for which purpose; furthermore, users agree with the necessary use of data and are informed about their rights.

### **1. Personal data**

Personal data are individual details about personal or factual circumstances of a specific or identifiable natural person. This includes information such as name, address, telephone number and birth date. Information which is not directly related to the real identity of a person – e.g. visited websites or number of users of a website – is not personal data.

### **2. Responsible party**

Responsible as defined by the data protection legislation is the Lawyer Thomas Tzotzou, Olympiou Diamanti Str. 14, GR-54626 Thessaloniki/Greece.

### **3. Data security**

The Law Office Thomas Tzotzou & Associates takes all necessary technical and organisational security measures to protect personal data against misuse and loss. All data is stored in a secure operating environment which is not publicly accessible. Where possible, confidential data is transferred using the HTTPS protocol with SSL certificate encryption.

### **4. Data processing, consent to the use of data**

When users visit our website [www.griechenland-recht.eu](http://www.griechenland-recht.eu), our web server will temporarily store the following data by default to ensure system security: connection data of the requesting computer (IP address), identification data of the browser and operating system type, our web page visited, date and duration of the visit. Additional personal information such as name, address, telephone number or e-mail address is not collected, unless these details are provided on a voluntary basis, e.g. in the context of a registration, a survey, a prize competition, or when executing a contract or requesting information. Our Law Office cannot allocate the automatically collected data to specific individuals. A compilation of this data with other data sources is not made, in fact it is deleted after a statistical analysis.

## 5. Cookies

The website [www.griechenland-recht.eu](http://www.griechenland-recht.eu) does not use any cookies. If we are use cookies, cookies are used which serve to make the site more user-friendly, effective and safe. Cookies are small text files allowing for the recognition of users. They are stored by the browser memory on the computer of the user. Most of the cookies used by Gretsch-Unitas are so called "session cookies" which are automatically deleted after the user has left the website.

## 6. Google Analytics

Our website maybe uses Google Analytics, a web analytics service provided by Google, Inc. ("Google"). Google Analytics uses "cookies", which are text files placed on your computer, to help the website analyze how users use the site. The information generated by the cookie about your use of the website will be transmitted to and stored by Google on servers in the United States. In case IP-anonymisation is activated on this website, your IP address will be truncated within the area of Member States of the European Union or other parties to the Agreement on the European Economic Area. Only in exceptional cases the whole IP address will be first transferred to a Google server in the USA and truncated there. The IP-anonymisation is active on this website. Google will use this information on behalf of the operator of this website for the purpose of evaluating your use of the website, compiling reports on website activity for website operators and providing them other services relating to website activity and internet usage. The IP-address, that your Browser conveys within the scope of Google Analytics, will not be associated with any other data held by Google. You may refuse the use of cookies by selecting the appropriate settings on your browser, however please note that if you do this you may not be able to use the full functionality of this website.
